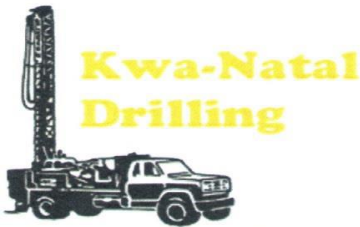

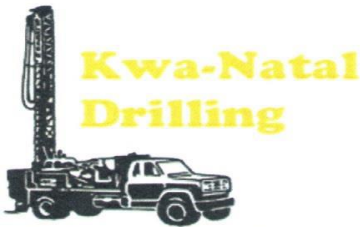

- includes provisions that are substantially similar to what is contained in this privacy policy to the further transfer of your data.

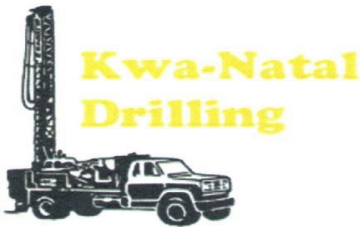
